POLL RESULTS OF ANNUAL GENERAL MEETING HELD ON 17 AUGUST 2021

The Board announces that at the Annual General Meeting held on 17 August 2021, all the resolutions as set out in the Notice of Annual General Meeting were duly passed as ordinary resolutions of the Company.

Reference is made to the circular (the “**Circular**”) of the Company and the Notice of Annual General Meeting issued to the Shareholders dated 15 July 2021 (the “**Notice of Annual General Meeting**”). Unless the context otherwise required, terms defined in this announcement shall have the same meanings as those defined in the Circular.

POLL RESULTS OF ANNUAL GENERAL MEETING

At the Annual General Meeting (the “**AGM**”) held on 17 August 2021, all proposed resolutions as set out in the Notice of Annual General Meeting were taken by poll.

As at the date of the AGM, the total number of issued shares in the Company (the “**Shares**”) was 1,668,656,816 shares, which was the total number of shares entitling the Shareholders to attend and vote for or against the resolutions at the AGM. There were no Shares entitling the Shareholders to attend and vote only against the resolution at the AGM, and no Shares entitling the holders to attend and abstain from voting in favour of any of the resolutions as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) at the AGM and no Shareholders were required under the Listing Rules to abstain from voting on any of the resolutions at the AGM.
